- All commercial booth spaces are 10' x 10'.
- Space Fee is \$25.00 for chamber members, \$35 for non-members, if postmarked on or before October 29, 2021
- Fees after October 29, 2021 is \$40 for chamber members and \$60 for non-members.
- Electricity is not available. If you use a generator, it must be a quiet one.
- No Music Played at the Booth Site
- Fees are NOT refundable after October 29, 2021
